TERMS & CONDITIONS**

**GENERAL:** The Biomimicry Guild in Helena, Montana (herewith referred to as the sponsor), will conduct a learning program at La Cusinga Lodge, Uvita, Costa Rica from March 24-31, 2010. Travel days to and from San Jose, Costa Rica are March 23 and April 1, 2010. By signing the APPLICATION & REGISTRATION FORM participants release the sponsor and its agents and employees from all liability arising from the conduct of the program. This release of liability shall include, but is not limited to, liability incurred during the participant's transit to, from, or during the program; liability for injury, damage, or loss occasioned by the acts or omissions of any person or company engaged by the sponsors to provide goods or perform services as part of the program.

By signing the APPLICATION & REGISTRATION FORM the participant understands the potential dangers of traveling and studying in a foreign country and agrees to assume the risk for all losses or additional expenses due to sickness, delay, strike, war, quarantine, weather, or other causes beyond the control of the sponsors and their agents and/or employees. Baggage is at owner's own risk entirely. All such losses are borne by the participant as the program price provides for arrangements only for the time stated.

**WITHDRAWALS AND CANCELLATIONS:** In the event the program must be canceled due to lack of subscription, or for any reason deemed sufficient, full refund will constitute full settlement with the participant. The sponsors reserve the right to accept, retain, or withdraw any person as a member of the program. In the event an enrollee is asked to withdraw because of behavior deemed detrimental to the group, no refund will be allowed. Enrollment includes participation in the program: no refund will be made to the participant for any unused portion, except for items which are refundable to the sponsors. No refunds will be made while the program is in progress. If a written request for withdrawal from the participant is received prior to February 1, 2010, addressed to The Biomimicry Guild, PO Box 575, Helena, MT 59624, full refund will be made except a \$100 non-refundable administrative fee. If written request for withdrawal is received between February 2 and 15, 2010 the sponsor will retain the \$500 deposit. For withdrawal requests made between February 16 and March 23, 2010 the sponsor will retain 50% of the full registration paid.

**CHANGES IN ITINERARY:** The sponsors reserve the right to alter any aspect of the program, to make cancellations, changes or substitutions in case of emergencies, or in the best interest of the participants, and to alter the price prior to departure in order to meet unexpected price changes. The announced fees are based on current tariffs, which may be subject to change beyond the sponsors' control.
